The CoC will also consider applications for new RRH projects specifically targeted to persons fleeing Domestic Violence/Human Trafficking.

*If you haven't received a previous stimulus payment, you may be eligible for a <u>*Recovery Rebate Credit*</u>. To claim the rebate, you must file a 2020 tax return. Details are available <u>here</u>.

COVID-19 Funeral Assistance

If you paid for funeral expenses after January 20, 2020, for an individual whose death may have been caused by or was likely the result of COVID-19 you can apply for up to \$9,000 for funeral assistance.

Detroit residents aged 12+* and those who work onsite in the city are eligible for free vaccines. Walk-ins are welcome at every location. To find the nearest vaccine location text your address to **313-217-3732**. To schedule an appointment, call **313-230-0505**,



In Detroit, those who transport a person to a vaccine site will receive a \$50 pre-paid card. To register, call **313-230-0505 and** schedule an appointment to qualify.

Emergency Broadband Benefit Program

The Emergency Broadband Benefit Program is a Federal Communications Commission (FCC) program that provides a temporary discount on monthly broadband bills for qualifying low-income households. If your household is eligible, you can receive:

Up to a \$50/month discount on your broadband service and associated equipment rentals

- Up to a \$75/month discount if your household is on qualifying Tribal lands
- A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (with a copayment of more than \$10 but less than \$50)
