# DEMAND OUR LEGISLATORS FULLY & IMMEDIATELY FUND RENTAL ASSISTANCE FOR OUR COMMUNITIES

Partisan politics is getting in the way of providing assistance to our most vulnerable citizens affected by the pandemic. We are all in a precarious position as state legislators threaten to appropriate funding on a timeline which does not help our communities *right now*. This funding is meant to keep people in their homes and keep their utilities on.

**Let me repeat:** federal funds have been disbursed to Michigan. It is here! However, it's legislators who are holding up these funds.

Contact the <u>Michigan Senate</u> & <u>Michigan House</u> Appropriations Committee members to tell them that we can't wait.

This is your opportunity to let MSDHA know how their PHA and HCV policies affect the amazing work happening in Detroit and with your agency.

  their regular job site
  State and Faderal law enforcement
- State and federal law enforcement officials who report to a job site
- Active clergy members whose ministry includes face-to-face contact with members
- Food service workers living or working in Detroit
- Security guards living or working in Detroit
- Janitors living or working in Detroit
