Celia T. opened the meeting at 1:30 pm with introductions – utilizing the chat box.

CAM Transition Update:

Summary –

- Two months into launching CAM, there has been a lot of changes. They recently held a CAM forum which was held to share information about CAM and provided an opportunity to receive feedback from the community. They are still in the transition period, some of the improvements that will be implemented will start in the new year.
- One of the concerns raised for CAM was that there were long wait times for the call line and that was due because of staffing changes at Wayne Metro; however, they are in the process of getting the new staff trained to improve that issue.
- For a couple of months, we have been experiencing a shortage of shelter beds; however, they have been working on this issue.
 - CoD opened their warming shelters to provide additional beds.
- By January, Cass and NOAH in person access sites will be publicly launched.

Strategic Updates

Summary –

- They had 10 community sessions on improving shelters, rehousing, and affordable housing supply. During these sessions, they developed strategies on how to address these issues.
